Payment Terms

Course Payment:

Payment Options

Payment Option 1: Full payment of AU\$880 required when booking.

Fees and GST

Course fees are paid in Australian Dollars (AU\$), and Doris Mounsey and Whole Health Kinesiology are not registered for GST

Security Policy

Payments are processed via PayPal or direct bank transfer to the Bendigo Bank account. Doris Mounsey does not keep any record of the student's Credit Card Details.

Refund Policy

I offer a partial refund to the participants who change their mind within the refund time frame. The refund time frame is defined as the period from your enrolment date to **3 days after the 3rd Online lecture**. This 3-week time frame allows you to experience 3 Online lectures and withdraw from the course in writing if the course content is not for you.

Your refund is calculated as the total of your payments made to this point in time minus the administration fee. The administration fee of AU\$100 covers administration time and your welcome pack.

Withdrawal from the course

If the student decides to withdraw from the course.

- You must notify Doris Mounsey in writing of your decision to withdraw.

Minor Problems

In case of internet cutting out through an Online lecture or tutorial, the recording is made available to the student.

If the internet cuts out for the lecturer, the Online session will be rescheduled, and you will receive an email with the new lecture/tutorial date.

In case of illness, the Online lecture/tutorial will be rescheduled by Doris Mounsey.

Doris Mounsey will be dealing with any minor problems on a case by case option, always intending to find a win/win solution to solve any issue.

Major Problems

Cancellation of the contract

If the student cancels the contract after the refund period, please contact Doris Mounsey immediately in writing. The refund depends on how much of the course content was already delivered.

Each week the student has had access to the course content and/or attended online sessions will be calculated with the value of AU\$100, plus AU\$100 to cover administration cost and the delivery of the welcome pack.

For example, if the student cancels after week 5, the calculation of the refund will be the following:

Course value calculation: 5 weeks multiplied by \$100 plus \$100 administration fee equals AU\$600

Refund calculation: your full payment (\$880/\$950/\$990) minus AU\$600 (Course value received)

Jurisdiction & Dispute Resolution

Negotiation

Suppose either of us have any concerns arising from this agreement or your participation in the Awaken your Intuitive Intelligence®. In that case, we agree that we shall communicate to make a genuine effort to seek a win/win solution and resolve any dispute by negotiation and discussion.

Please, raise any of your concerns as soon as you become aware of the problem; please choose your most comfortable way of communicating your concerns by phoning or writing to Doris Mounsey.

All information exchanged during this meeting or any subsequent dispute resolution process shall be regarded as "without prejudice" communications for the purpose of settlement negotiations and shall be treated as confidential by everyone involved and their representatives unless otherwise required by law. However, evidence that is independently admissible or discoverable shall not be rendered inadmissible or non-discoverable by virtue of its use during the dispute resolution process.

Mediation

If we are unable to resolve a dispute by negotiation and discussion within 14 days, we agree to proceed to mediation with the assistance of an independent accredited mediator, seeking online dispute resolution or mediation by telephone if we are not both in Victoria, Australia.

The mediator is to be appointed by agreement between us or failing agreement within 21 days of the negotiation period ending. The person initiating the dispute will seek the appointment of a dispute resolution professional by the President of the Law Society of Victoria, Australia.

We agree to share all the costs of mediation equally between us.

We agree that neither of us will commence legal action until, in the opinion of the independent mediator, the potential for negotiation and mediation have been exhausted.

Mutual Non-Disparagement

Everyone involved agrees that they will not publicly or privately disparage any other party to this agreement or anyone associated with them and will act in good faith to refrain from any conduct or communication which might reasonably be expected to interfere with any other party's business or personal interests.

Jurisdiction

This agreement is subject to the governing laws of Victoria, Australia. Regardless of where you live in the world, you irrevocably agree that if the dispute resolution processes fail, the courts of Victoria, and the Commonwealth of Australia, will have exclusive jurisdiction.
